Positive Impact Health Centers is a non-profit agency founded in 1990 that provides HIV Prevention Education, Support Services, Ric Crawford Clinic, Housing, Volunteer Programs and Advocacy to the Atlanta Metro Area.

**General Narrative Description of Position:** The CTL counselor is responsible for implementing Counseling, Testing and Linkage public health strategy for identified high-risk. Populations in the Duluth Center service area. This position is supervised by the HIV Program Manager.

## **Essential Job Functions:**

- 1. Conducts HIV Counseling (CTL) sessions in a non-judgmental manner and with fidelity to the core elements and core components of the HIV Prevention Counseling standards.
- 2. Documents testing session accurately on the HIV Test Report forms, Consent Form, HIV Adult Case Reports and other assigned forms and then compiles data into a monthly report, the numbers tested, successes and challenges and submits report to supervisor by the 10<sup>th</sup> business day of the following month.
- 3. Works in an independent and interdependent relationship with members of the prevention services staff, which allows for consultation, collaboration, and/or referral.
- 4. Implements the Counseling, Testing and Linkage services related to HIV testing as outlined in the grant contract and adheres to the standard operating procedures and quality assurance standards.
- 5. Recruits targeted high risk persons for testing services, including participating in outreach events.
- 6. Helps CTL services meet or exceed the yearly objectives or documents the extenuating factors that interfered with obtaining the objectives.
- 7. Takes the lead in providing rapid testing, counseling and linkage to care during peak CTL hours and at regular offsite events.
- 8. Responsible to collect demographic information and the information needed to accurately complete the CDC HIV Report forms.
- 9. Provides CTL Counseling adhering to the counseling concepts and guidelines learned in the Fundamentals of HIV Prevention Counseling course.

- 10. Assist in the maintenance of an accurate inventory for the HIV rapid test kits used for testing services.
- 11. Assist in the documentation of CTL services provided is accurately completed, including all forms, logs and data base entries.
- 12. Assist in re-ordering kits for the testing program in a timely manner to ensure they are always available.
- 13. Ensures that agency condom and lubricant distribution receptacles are always at least half full.
- 14. Abide by all state and district policies regarding confidentiality of client information.
- 15. Assists in the scanning of documents to the appropriate network folders.
- 16. Must perform job duties in a professional manner, including arriving at program sites early so that set-up occurs and sessions are started on-time.
- 17. Remain current on HIV/AIDS issues.

## **Additional Duties:**

- 1. Network with other agencies, funders, and others to promote Positive Impact Health Centers' HIV Prevention services.
- 2. Participate in monthly agency staff meetings, monthly departmental meetings and health education trainings as directed.
- 3. Assist in the provision of HIV testing to other targeted groups in the agency as well as in the community setting.
- 4. Leads and/or supports the organization of special events as assigned.
- 5. Performs other duties as assigned

#### Marginal Job Functions:

1. General prevention supply room housekeeping.

#### **Required Knowledge, Skills and Personal Qualifications:**

- 1. Bachelor's Degree preferred, high school degree or GED required.
- 2. Possess excellent communication skills (writing, spelling, listening and speaking).
- 3. Completion of HIV Prevention Counseling training courses preferred.
- 4. Proficiency in word processing, spreadsheet database and presentation software.
- 5. Competent in data entry.
- 6. Bi-lingual Spanish/English preferred.
- 7. Able to be a self-starter with the ability to multi-task.
- 8. Cooperates as a team member.
- 9. Possesses problem solving and decision making abilities

- 10. Ability to work without close supervision
- 11. Follows through to completion of assigned tasks.
- 12. Abides by all policies and procedures concerning personnel including conflict of interest policy.
- 13. Due to the nature of work, the applicant is required to pass a police background check and pre-employment drug screening.
